



**APPLICATION and PROCESS FOR SUMMER 2010 FINANCIAL AID**

**What can I apply for:**

The ONLY financial aid available for the summer is the Federal Pell Grant and Stafford Loans.

**\*PELL:** Your Pell Grant eligibility is based on the number of credits you were previously paid for in the fall and spring terms of 2009-2010. If you did not submit a Summer Application and you are registered for classes, you will automatically be considered for a summer Pell Grant and receive email notification regarding your eligibility.

**\*Bergen Community College will participate in the Year-Round Pell starting the Summer of 2011.\***

**\*Loans:** Your loan eligibility is determined on whether or not you have left over loan funds based on maximum eligibility requirements [see reverse]. There is a six [6] credit minimum requirement. If you are requesting a loan please complete the information below and the information on the reverse side of this form.

**When will I receive my summer award?**

Payment is due upon registration for summer terms. *After* submission of your summer application please check your web-advisor for the amount of aid that will be credited to your account for the summer term[s] you are registered for. Loan funds are disbursed in two [2] payments: at the mid point and the end of the term.

**Please Note:** Summer loan aid is prorated based on the number of weeks of class enrollment and a minimum of six [6] credits.
